We believe the most transformational, holistic, sustainable, and long-term change occurs when one community partners with another. Children's HopeChest engages churches, businesses, and other Christian communities in long-term partnerships that help orphans survive, thrive and succeed within their home cultures by:

* Empowering local leaders to share the Gospel, reduce poverty, and create self-sufficiency for every child.

* Equipping partnering communities to directly engage in healthy, international development practices.

Development projects involve the setup of such infrastructure as water systems, churches, schools, and libraries. They also fund sustainability - promoting programs that include artisanship, agriculture, micro-finance, and vocational business leadership. These projects help HopeChest reach the broadest audience surrounding orphaned and vulnerable children.
